

SELECTMEN'S MEETING

JUNE 4, 2024

MINUTES

Selectmen in Attendance: Dick Norcross, John Hicks and Frank Day.

Chairman, Dick Norcross called the meeting to order at 5:31 PM and called for a Pledge of Allegiance.

John motioned, Frank second to approve the Minutes of May 21, 2024 Selectmen's Meeting. Voted unanimously by a show of hands.

Payroll (and Accounts Payable) have been approved.

The Board agreed to schedule a meeting with Alex Parker, Esq., during the day in a couple of weeks to discuss the process of Brownfield approving recreational sales of marijuana.

The Franchise Agreement is ready for signatures but we don't have a map. Dick said that we do not have a map but we have an address list, he will ask for a map. Frank asked if all of the other towns have signed it and Dick said that they have. Fryeburg and Denmark decided to do their own thing. Dick said they will pull it to the house for underground. This is a two-year process and prices seem to be going down.

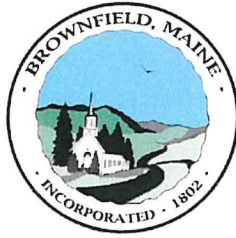

The next safety building committee meeting is scheduled for June 6 @ 7AM.

Dicky asked to be the authorized agent to sign the grant and applications to keep the process going for the new safety building. Dick made a motion, John second to make Dicky the agent. Voted unanimously by a show of hands.

We still do not have a reply from Matt Randall in regards to Farm vs farm animals.

Dick said a lady wants to cut trees by the pond. It was suggested that she might contact her insurance company and/or the DEP.



Vinny Carbone discussed issues with Zack and he wants the Board to invite Sheriff Wainwright to come to a meeting here. He wants to know where all the emails are from Megan Witt. His inability to go on the Brownfield Rec page, he said he is still being slandered. He said the former board denied him the right to know his accusers. Dick said he will call Sheriff Wainwright. Vinny said he is a citizen too and discussed the cyber bullying with fake Facebook accounts while he was Selectman and there is unfinished business that nobody wants to talk about it. Frank responded that as the Board of Selectmen they have to be really careful what they say, they have things going on that they can't talk about so it seems like nothing is being done. Vinny said this has been over ten years and nothing is getting done. Siting the Brownfield Matters Facebook page. Bruce said that this isn't an isolated incident with Vincent Carbone because some of the same stuff happened to him. Bruce also said this was prior administration and that this Board has to pick up the broken pieces. Frank asked Dick if he knew why Vinny was banned from the Rec Facebook account. Dick said he didn't know how but it was over Zack and said we can ask Willy. Dick asked Frank to talk to Willy. John explained that we will give the information to the Town Attorney.

Frank motioned, John second to adjourn. Voted unanimously by a show of hands.
